- **Ruse Park:** Mayor Ellis advised Council that a ribbon-cutting ceremony for Ruse Park is scheduled for November 22, 2025, at 11:00 a.m. The first 24 children in attendance will receive a whistle and a conductor's hat.
- **Dog Park:** Mayor Ellis reported that construction of the dog park is expected to be completed tomorrow. The area will include benches, plastic fire hydrants, and four (4) waste-disposal stations equipped with bags.

- **CADE Partners:** Mayor Ellis reported that the City is currently in negotiations with Woody DeLong of CADE Partners regarding the existing agreement under which CADE Partners loaned funds to the City to satisfy a prior lawsuit and currently holds the deed to the Police Department building. The Mayor advised that negotiations are underway for a potential early payoff of the obligation, and that CADE Partners has indicated a willingness to reduce the outstanding balance by Fifty Thousand Dollars (\$50,000.00) if the City elects to pay the balance early.

Donald Roberts asks how much is still owed on the loan. Mayor Ellis says we still owe about \$414,000. The interest rate is about 5%
